

INTRODUCTION

Parliament has gone on recess for the First Meeting of this Session. They are expected to reconvene in May to continue with parliamentary business for the Second Meeting of the Second Session.

Member for Damongo and Minister responsible for Lands and Natural Resources, Mr. Samuel Abu Jinapor, made a statement on **the historical and contemporary contribution of the Savannah Region** to the country's political and socio-economic development on the occasion of the Sixty-Fifth Independence Anniversary of Ghana.

The Hon. Member for Gomoa East, Mr. Desmond De-Graft Paitoo, made a statement on the theme “**Forests and sustainable production and consumption**” in commemoration of the International Day of Forests” which falls on the 21st day of March each year.

CONCLUSION AND RECOMMENDATIONS

- The controversial **Electronic Transaction Levy Bill, 2022** was passed after the minority Caucus in Parliament walked out.
- The Supreme Court of Ghana ruled that **a Deputy Speaker who is presiding over a Sitting retains his right to vote during decision making** in the plenary. The ruling attracted reactions from the Minority as they played to the issue of a quorum for parliamentary sitting. This has the tendency of stifling government business going into the future.
- The issue of **tax exemptions attracted reactions from MPs and experts** concerning the revenue the country is losing and the need to pass the Exemptions Bill to curb the menace. The bill is before the Finance Committee and is **likely to gain momentum for its passage in the next Meeting**.

- The Speaker of Parliament on the 5th of April, having received a petition by some civil society organisations **ruled on the attendance of three (3) Members, and referred them to the Privileges Committee** through a motion of urgency to report to the House in two weeks after Parliament reconvenes in May.
- The Speaker, Alban S.K Bagbin in a statement during the plenary on 5th April, 2022, noted that the work of Parliament is being monitored by CSOs across Africa. He, therefore, admonished Members to be as honourable as possible in their attendance and work as legislators. This follows a **meeting the Africa Parliamentary Monitoring Organisations Network (APMONs) Working Group, led by Parliamentary Network Africa (PNAfrica)**, held with the Speaker on the 31st of March, 2022 at Parliament. The Speaker in addressing the Network expressed his willingness to work together in making parliament more transparent, accountable and open to citizens for meaningful participation.
- The nature and composition of the current Parliament calls for civil society support to work with parliamentarians to effectively conduct parliamentary business. So far, the ‘Hung Parliament’ has not produced expected results which calls for CSOs to help strengthen the work of Parliament.
- The House went on recess on Tuesday 5th April, 2022 and is expected to reconvene in May 2022 for the Second Meeting of the Second Session of the Eighth Parliament.
